2. The comparative financial information of the Company for the corresponding quarter and year ended March 31, 2022 were audited by the predecessor auditor who expressed an unmodified opinion vide their report dated 30th May, 2022.

We have placed reliance on the reports given by predecessor auditor for the purpose of our report on the Financial results for the corresponding quarter and year ended March 31, 2022.


